BULL PERFORMANCE TEST & SALE GUIDELINES

1. Membership Requirements

- a. Consignor must be a current member in good standing with OKRAA

2. Location

- a. Bulls will be fed at Chain Ranch Bull Development Center 237809 State Hwy 51 Canton, OK 73724
- b. Bulls will be sold at the Reds in the Heartland Sale hosted at OKC West Livestock Market on April 5, 2025

3. Bull Registration & Age Requirements

a. Registrations

- i. Must be in R status with the RAAA as of sale date.
- ii. Must be a 1A or 1B with the RAAA.
- iii. No Categories 2 or 3 will be allowed

b. Ages

- i. Bulls birthdates will be August 1, 2023 thru March 15, 2024

4. Entry Requirements

a. Entry fee

- i. There is a \$50 nomination entry fee per bull.
- ii. Entry fee is nonrefundable and will not be applied to any sale expenses.

b. Weaning

- i. Bulls must be weaned 30 days prior to delivery date
- ii. Weaning information must be entered in RedsPro with the RAAA

c. Identification

- i. Must be tattooed with legible id numbers and herd prefixes
- ii. If tattoos are not legible or not done at all, there will be fee assessed to tattoo the bull and/or correct the tattoo.
- iii. All bulls will be assigned a feedlot identification number for the test
- iv. Bulls are required to have either an EID tag or USDA issued silver tag.

d. Feeding

- i. Bulls being trained to eat from a feed bunk is not required but is recommended
- ii. Bulls will be fed for a two-week warm up period before official start weight is taken.

5. Health & Soundness Requirements to Enter Test

a. Scrotal

- i. Bulls that are 12 months of age or will be by November 1, 2024 must have a minimum 30 cm scrotal measurement.

b. Health Requirements

- i. Bulls must have a BVD PI Negative Test.
- ii. Bulls must have two doses of respiratory and colostridial vaccinations. These should include IBR, BVD TYPE 1&2, PI3, BRSV, Colostridial 7,8, or 9 way. Pasturella Haemolytica and Pasturella Multiocida.
- iii. Bulls must be Dewormed
- iv. Bulls must be vaccinated for warts.
- v. Booster IBR, dewormer and delicer will be given at feed yard.
- vi. Free from Blemishes, pink eye, ring worm, warts etc.
- vii. Must be sound and free from hoof deformities

Health & Soundness Requirements to be Met During Test to Make Sale

- a. ADG**
 - i. Bulls must have a 2.0 ADG at the end of the test.
- b. Scrotal/Breeding**
 - i. Bulls must have a minimal scrotal measurement of 32 cm.
 - ii. Bulls must pass a Breeding Soundness Exam. Results of exam will be provided at the sale.
- c. Soundness**
 - i. Bulls must be structurally sound and free of any hoof deformities.
- d. Health**
 - i. Bulls must have a negative trich test. Results of test will be provided at the sale.
 - ii. Bulls must be free of warts, blemishes, pink eye, ring worm, etc.
 - iii. Bulls must have a desirable disposition to be sold
 - iv. Feed Yard will have a health paper accompanying each bull to the sale

Expenses/Catalog

- a. Entry Fees**
 - i. Entry fee is nonrefundable
- b. Commissions**
 - i. Sale Expense will be a minimum 15% or less if fees allow
 - 1. Example a \$3000 animal through the sale will net \$2550 to owner
 - 2. Example a \$1500 animal through the sale will net \$1275.
 - ii. No Sale Fee will be the commission multiplied by the last bid through the sale ring.
- c. Scratches**
 - i. No bulls may be removed from the test by the consignor without penalty
 - ii. If a bull is removed from the test for any reason other than by the test committee or test facility, the consignor will be assessed commission on the average of all bulls through the sale.
 - 1. Example, if the average of the bulls are \$3500 and the commission is 15%, the consignor will be required to pay \$525 on the animal removed from the test
- d. Photos/Videos**
 - i. The feed yard will be responsible for picturing and videoing each bull for the sale.
 - ii. Consignor will be responsible for the expense of the photos and videos, which will be deducted from the settlement sheet.
- e. Footnotes**
 - i. The consignor will be responsible for footnotes of their animal.
- f. Catalog Advertising**
 - i. Retail price is \$500 for a full page, ½ page \$300, business card \$100.
 - ii. Consignors will receive 50% discount for ads placed in the catalog.
- g. Other Expenses**
 - i. The feed yard will assess each consignor a feed bill during the test
 - ii. The feed yard will assess each consignor for any veterinary services such as vaccinations, worming, semen evaluations, issuance of health papers, etc.
 - iii. The feed yard will assess each consignor for clipping services to prepare animals for picture and video day
 - iv. The feed yard will conduct a DNA/Genetic 50K test. Unless consignor has already performed and provides documentation to OKRAA. This test is \$50 and will be assessed to the consignor

BULLS TEST SCHEDULE

- ✓ Bulls should be delivered by 1:00 p.m. on Oct 12, 2024

➤ **December 20-30**

- ✓ Weight on all bulls and pour for internal and external parasites.

➤ **February 10-15**

- ✓ Weights on all bulls and delice. Torch and Clip, Lot Tags

➤ **February 28- March 7**

- ✓ Picture & Video Bulls

➤ **March 7**

- ✓ Weight on all Bulls
- ✓ Start Breeding soundness exams (BSE) and Trich Testing
(All bulls will be fertility checked and trich tested to qualify for sale)

➤ **April 4**

- ✓ Bulls delivered to OKC West Livestock for viewing for the Sale.

➤ **April 5**

- ✓ The Reds in the Heartland Sale at OKC West Livestock

- Test committee and test facility have right to refuse any bull deemed unacceptable for sound animal husbandry practices.
- All decisions by the Test Committee is final.
- All animals will be guaranteed by the seller as outlined in the Red Angus Association of America code of ethical sale practices.
